3. <u>Self-Regulatory Organization's Statement of the Purpose of, and Statutory Basis</u> for, the Proposed Rule Change

a. <u>Purpose</u>

The Exchange proposes to amend footnote 14 referenced in Section 1)a)iii) of the Fee Schedule to amend the list of Select Symbols contained in the PCRP to remove the Select Symbol "X," (United States Steel Corporation) from the Select Symbols list.

The Exchange initially created the list of Select Symbols on March 1, 2014,⁵ and has added and removed option classes from that list since that time.⁶ Select Symbols are rebated slightly higher in certain PCRP tiers and segments than non-Select Symbols.

On June 18, 2025, the Exchange issued an alert that it would delist United States Steel Corporation options from trading on the Exchange, effective June 20, 2025.⁷ Options on United States Steel Corporation were authorized to be listed for trading on the Exchange pursuant to Exchange Rule 402, but are no longer listed for trading for business reasons.⁸

b. Statutory Basis

The Exchange believes that its proposal to amend its Fee Schedule is consistent with Section 6(b) of the Act⁹ in general, and furthers the objectives of Section 6(b)(4) of the Act¹⁰ in particular, in that it is an equitable allocation of reasonable fees and other charges among its members and issuers and other persons using its facilities. The Exchange believes that the proposal to amend an option class that qualifies for the credit for transactions in Select Symbols is fair, equitable and not unreasonably discriminatory.

The Exchange believes that the PCRP itself is reasonably designed because it incentivizes

Select Symbols contained in the PCRP in order to avoid potential confusion on the part of market participants and other competing options exchanges.

The foregoing rule change has become effective pursuant to Section 19(b)(3)(A)(ii) of the Act, 13 and Rule 19b-4(f)(2)14 thereunder. At any time within 60 days of the filing of the proposed rule change, the Commission summarily may temporarily suspend such rule change if it appears to the Commission that such action is necessary or appropriate in the public interest, for the protection of investors, or otherwise in furtherance of the purposes of the Act. If the Commission takes such action, the Commission shall institute proceedings to determine whether the proposed rule should be approved or disapproved.
